Duties and Responsibilities

- Provide a high-quality learning environment in order to develop student potential within the Academy.
- Teach acting classes across all four years of the undergraduate Musical Theatre programmes as well as teaching and training undergraduates from other SPAA programmes.
- Assist the Programme Leader Musical Theatre, Lead Tutors and other colleagues in planning, creating, delivering and maintaining high standards in actor training.
- Undertake administrative, reporting and reflective processes for both internal and external partners and key stakeholders.
- Fully embrace SPAA's Practice as Research programme, making key contributions to generic and specific activities.
- Lead projects, direct and devise work.
- Support outreach to international, regional and local communities.
- Contribute to admissions and audition procedures.
